2013 CASWELL DISTINGUISHED SERVICE AWARD RECIPIENT: DR. ELIZABETH WITH



The Dr. Jim Caswell Distinguished Service Award is the highest honor bestowed by TACUSPA. The award recognizes a member who has been a TACUSPA member for at least 10 years, shown high quality leadership performance in student affairs at the state, regional or national level, and made contributions above and beyond normal service required by positions of leadership.

This year's winner of the Caswell Award is Elizabeth With. Dr. With currently serves as the Vice President for Student Affairs and Enrollment Management at the University of North Texas after being named Vice President for Student Affairs in 2010. Prior, she served as the Associate Vice President for Student Development (2004-2009), Assistant Vice President for Student Development (1998 - 2004) and Assistant Dean of Students (1996-1998) at UNT. She has also held positions at The University of Texas at Arlington and Texas Tech University. Her current responsibilities include overseeing all areas of the Division including, Admissions, Career Center, Center for Leadership and Service, Center for Student Rights and Responsibilities, Dean of Students, Dining Services, Greek Life, Housing and Residence Life, Orientation and Transition Programs, Recreational Sports, Campus Life, Student Financial Aid and Scholarships, Student Health and Wellness Center, Student Legal Services, Student Money Management Center, TRIO programs, and the University Union.

Dr. With received her doctorate in Higher Education Administration with an emphasis on legal issues in higher education from the University of North Texas. She received both her B.A. in English and her M.Ed. in Educational Psychology from Texas Tech.

A member of the Leadership Texas Class of 2006, Dr. With holds current membership in numerous professional organizations and is a former President of the Texas Association of College and University Student Personnel Administrators (TACUSPA).

Dr. With has been a member of TACUSPA for 20 years and has served in multiple leadership positions within the organization since 1994, including President, Secretary, and Conference Chair. Dr. With will receive her award at the fall 2013 TACUSPA conference business meeting.

COMMUNITIES OF PRACTICE

In August, TACUSPA announced a new initiative that aims to prompt timely discussion of important issues in Texas higher education. The program is called Communities of Practice (CoP) and is based on a common model of collaborative learning in which participants teach and learn from each other. There are presently four communities of practice. Each is led by a TACUSPA volunteer.

CoPs include the Assessment and Evaluation community, led by Kasey Neece-Fielder of The University of Texas at San Antonio, the Spirituality community led by Jon Bartlett of the University of North Texas, the Communities Colleges community led by John Jacobs of Austin Community College and the Student Persistence and Success community led by Rosalind Alderman of St. Mary's University.

Nearly a year in the planning stages, the communities feature an interactive forum for all members on the TACUSPA website as well as blog posts on the topic from the CoP leader and invited guests. In order to participate, TACUSPA members must log onto the website. Additionally, conference attendees will notice that select educational sessions will be highlighted within the conference program as being endorsed by the various CoPs.

Planning and discussion is underway to expand the number of communities offered, to increase the educational opportunities offered and to encourage active participation in the communities. Members are encouraged to check them out on the TACUSPA website!

CASE STUDY COMPETITION

The 2013 TACUSPA Case Study Competition will take place at the annual conference in Houston. Individuals who register for the competition will be placed on teams with other participants from across Texas, and each team will be given a case to analyze while attending the conference. Teams will present their solutions and receive feedback on their performance by a panel of judges consisting of faculty and highly experienced practitioners. The Case Study Competition winning team will be announced and presented an award during the conference award ceremony on Tuesday.

If you remember the few emails I sent out to market the 2013 conference, these were just a few of the reasons folks mentioned as why the TACUSPA organization and the conference are so meaningful. And this doesn't even include what we all expect from a conference; networking, sharing of ideas and concerns, dialogs about solutions, learning new skills, etc.

If you're like me, it gets harder and harder every year to commit yourself to participate in professional travel.
